ORDER:-

Through 1<sup>st</sup> reference read above the Government notified District Mineral Foundation Trust Rules, 2016.

**2.** The Director of Mines and Geology, vide reference 2<sup>nd</sup> read above, informed that Smart Andhra Pradesh Foundation ('SAPF') created by Government of Andhra Pradesh have requested the Government to nominate District Level Programme Officer of SAPF as one of the members of District Mineral Foundation (DMF) at District Level and CEO / COO of SAPF as a member in State Level Advisory Committee.

**3.** It is observed that SAPF has been working with similar programs and objectives as DMF. Accordingly, the Director of Mines and Geology has submitted proposals to nominate District Level Programme Manager / Officer of SAPF as one of the members of Governing Council of District Mineral Foundation in each of the 13 districts and the CEO / COO of SAPF as a member in State Level Advisory Committee.

**4.** The Government, after careful examination of the proposals of the Director of Mines and Geology, hereby amends the District Mineral Foundation Trust Rules, 2016 for effective implementation of the program by nominating officers of SAPF as members in the District Mineral Foundations at the districts.

**5.** The following Notification of Amendment shall be published in an extra-ordinary issue of the Andhra Pradesh Gazette, dt:06-04-2016.

**NOTIFICATION**

In exercise of the powers conferred by Section(4) of Section(15), Sections 15(A) and 21 read with Section 9B of the Mines and Minerals (Development and Regulation) Act, 1957 as amended by the Amendment Act, 2015, the Government of Andhra Pradesh hereby issues the following amendments to the Rules issued in G.O.Ms.No.36, Industries & Commerce (M.II) Department, dated:14.03.2016.

**AMENDMENT**

1. In the Rule 5(i) of the District Mineral Foundation Trust Rules, 2016, after Sl.No.(t), the following shall be inserted:-

“(u). District Level Programme Manager / Officer of Smart Andhra Pradesh Foundation (SAPF)”

2. Under PART – II relating to definition of Affected Area, after Rule 2 (b) (vi), the following shall be inserted:

“(vii) A smart village or ward or habitation, which is situated or falls under or is in the neighbourhood or close proximity of any of the above defined categories of affected areas.”

3. In Rule 9, after sub-rule (b), the sub-rule (b) (i) shall be inserted as follows:

“(b) (i) works identified under Rule 2 (b)(vii) shall be taken up on priority basis”.

**6.** These orders shall come into force with immediate effect.
