'The Dead Rent, Royalty under Rule 27(2) and as per covenants in Form J under Rule 31 of Mineral Concession Rules, 1960 including other statutory payments for major minerals and the Dead Rent, Seigniorage Fee as per covenants in Form-G under Rule 8 and Rule 10 of Andhra Pradesh Minor Mineral Concession Rules, 1966 including other statutory payments shall exclusively be paid through online service facilitated in AP-Portal of Government of Andhra Pradesh (i.e. mee-seva) with immediate effect'.

NOTIFICATION – II

'The filing of Form-A for major minerals as per Rule 27(2) of Mineral Concession Rules, 1960 and G.O.Ms.No.674, Industries & Commerce (M.I) Department, Dt.27.06.1975 and Form K for minor minerals under Rule 34 of Andhra Pradesh Minor Mineral Concession Rules, 1966 and generation of transit forms, filing of dispatch particulars, filing of returns shall exclusively be through online service facilitated in AP-Portal of Government of Andhra Pradesh (i.e. mee-seva) with immediate effect'.
