ORDER

In the circumstances reported by the Director of Mines & Geology in the reference 2nd read above, Government after careful examination of the matter, hereby decide to issue an addendum to the amendment issued for incorporate for a separate item for Kuppam Grey Granite, in G.O.Ms.No. 131, Ind. & Com. (M-II) Dept., Dt. 04.10.2017, for inclusion of two more mandals i.e., Kuppam and Gudipalli mandals of Chittoor District in addition to the Santhipuram & Ramakuppam mandals which were already mentioned in the said G.O.
