Order:

In the circumstances reported by the Director of Mines & Geology, Government of Andhra Pradesh, Ibrahimpatnam, Vijayawada in the reference read above, after careful examination of the proposal of the Director of Mines & Geology, GoAP, the Government hereby constitutes a High Power Committee to deal with the financial and other related matters involved in the e-Auction of the 6 Limestone Blocks (one cement Grade Limestone in Machavaram Mandal of Guntur District, one cement Grade Limestone in Kolimigundla Mandal of Kurnool District and 4 Lime Stone Blocks at Mittagudipadu Block-I,II,III&IV) and 1 Gold & Silver Block in Gudipalli Mandal of Chittoor District for finalizing the value of the blocks, fixation of reserve price, eligibility criteria, end-use requirement etc, with the following members:-

2. The tenure of the above mentioned High Power Committee will be till 31st March, 2020. The Senior most Secretary to Government present in the meetings may chair the meetings and approve the minutes.

3. The terms of reference of the committee for the decisions are as follows:-

- (a) Who will be responsible for carrying out the entire auction process
- (b) Constitution of Technical Evaluation committee for evaluation of bids.
- (c) Price of tender document
- (d) Bid security amount
- (e) Reservation of mineral block for particular end use and specifying permissible end uses for auction
- (f) Eligibility criteria
- (g) Fixation of Reserve Price
- (h) Parameters for Mine Development and Production Agreement (MDPA) like minimum production requirement
- (i) Performance security appropriation events
- (j) Timeline for submission of application for reassessment of performance Security amount before expiry of the performance security validity period
- (k) Timeframe for automatic extension of bids - for example 10 minutes
- (l) Minimum increment of percentage of Price Offer to be submitted by Qualified Bidder – for example 0.05%.

4. The Director of Mines & Geology, Andhra Pradesh shall take necessary further action accordingly.
