ORDER:

In the G.O.2nd read above, Government have issued orders fixing the rate of Seigniorage Fee and Dead Rent for the 17 minor minerals mentioned therein by amending the Schedules I and II of the rule 10 of the Andhra Pradesh Minor Mineral Concession Rules, 1966 issued in the G.O. first read above.

2. Based on the report of the Committee, which was constituted to study and examine the matter with regard to reduction of seigniorage fee for low quality colour granite in Chittoor District, the Director of Mines & Geology has submitted a proposal to the Government, vide reference fifth read above, to make an amendment to rule 10 of APMCM Rules, 1966, for incorporating a separate item for "Chittoor Colour Granite (Other than Silver-waves, Madanapalli white and Iscon white)" in the schedule of rates as Sl. No. 17-6 in Schedule -I (rates of Seigniorage Fee).

3. After careful examination of the proposal received from the Director of Mines & Geology, Andhra Pradesh, the Government hereby decided to amend rule 10 of Andhra Pradesh Minor Mineral Concession Rules, 1966, duly incorporating a separate item for "Chittoor Colour Granite (Other than Silver-waves, Madanapalli white and Iscon white)" in the schedule of rates as Sl.No.17-6 in Schedule – I (rates of Seigniorage Fee).

4. Accordingly, the following Notification will be published in the Extra-ordinary issue of the Andhra Pradesh Gazette, Dated.21.02.2019.
