The following notification shall be published in the Andhra Pradesh Gazette.

NOTIFICATION

In exercise of the powers conferred under the proviso to Article 309 of the Constitution of India and of all other powers hereunto enabling, the Governor of Andhra Pradesh hereby makes the following amendments to the Andhra Pradesh Mining Service Rules, issued in G.O.Ms.No.59, Industries and Commerce (M.I) Department, dated.10.03.1998 and published in Part-I of the Andhra Pradesh Gazette, dated 16th March, 1998 as subsequently amended from time to time.

AMENDMENT

In the said Rules,

<u>Class-I, Category-1(A)</u> Additional Director of Mines & Geology	By promotion from "Category-2"	No person shall be eligible for promotion unless he has put in not less than (2) years of service in the category of Joint Director of Mines and Geology from which promotion is made.
